



ServSafe Alcohol Program Roll-Out Guidelines:

WISCONSIN

In Wisconsin, responsible alcohol service training is mandatory. Applicants for an operator's license must have completed a responsible alcohol service training program. ServSafe Alcohol® is an approved program in Wisconsin. There are some exceptions which can be found at <https://www.revenue.wi.gov>.

The state requires completion of the Wisconsin Tobacco training online course in addition to the ServSafe Alcohol Online course. **To ensure compliance is met, please adhere to the following steps:**

- Take the Wisconsin Tobacco online course. For more information, click [here](#).
- Purchase the ServSafe Alcohol Online Course and Primary Exam (SSAOLP3), which also includes a Wisconsin state supplement and Wisconsin state quiz.
- Take the ServSafe Alcohol Online Course, download and review the Wisconsin state supplement and then take both the Wisconsin state quiz and ServSafe Alcohol Primary Exam.
- Apply for an Operator's (bartender's) license with your local municipality. For more information, click [here](#).

In order to teach the ServSafe Alcohol classroom course in the State of Wisconsin you must:

- Pass the ServSafe Alcohol Primary Wisconsin exam.
- Be an approved ServSafe Alcohol Instructor (Instructors must order the Wisconsin version of the paper exam booklet).
- Obtain the Wisconsin Supplement from ServSafe.com under the Alcohol Instructor Resource Center or via the content within the WI SSA Online Course.
- Learn Wisconsin tobacco vending laws by completing the Wisconsin Tobacco online course & exam – For more information, please visit: <https://witobaccocheck.org/exam/start?trainingId=7398.ServSafe%20Alcohol%20Instructors> – you should have your class participants complete this either before your training with proof of completion or at the training.
- Apply for an Operator's (bartender's) license with your local municipality. For more information, click [here](#).
- Give the Wisconsin Exam and return answer sheets to the National Restaurant Association for grading.
